EXTENSION OF FEE SUBMISSION DEADLINE FOR MONSOON SEMESTER 2020-2021

1. All pre-registered students who failed to submit the semester fee for Monsoon Semester 2020-21 by 30 September 2020 are hereby informed that the last date for submission of Semester fee has been extended. The students can pay the fee from **15 October 2020 to 31 October 2020** along with a fine of **Rs. 5000/-**.
2. As per the guidelines for refund shared on 14 September 2020, the students who could not pay the fee as per point 2 of the said guidelines are not required to pay the fine, provided they submit the proof of deduction of payment from the bank account along with the failure notice latest by 20th October 2020 to refund@iitism.ac.in. The date of payment transaction in all such cases should be **on or before 30 September 2020**.
3. (a) The fee along with the fine shall be deposited **through Parent Portal**. The fee amount on the parent portal includes the fine amount of Rs. 5000/- now.
(b) **For Loan Cases only:**
 - (i) The payment may also be made **through SBI Collect**. However, the transaction receipt will be required to be uploaded by the student on the parent portal in this case.
 - (ii) The payment may also be made **through direct transfer in Institute Bank Account** (SBI Bank Acc. No. 37052697697, IFSC: SBIN0001641, ISM Campus Branch, Dhanbad). The transaction details must be sent to feepayment@iitism.ac.in in this case so that a **fee receipt** can be issued which would be required to be uploaded by the student on the parent portal.
4. The students who have paid the semester fee **after 30 September 2020** are required to pay the fine of Rs. 5000/- in the Institute Bank Account (SBI Bank Acc. No. 37052697697, IFSC: SBIN0001641, ISM Campus Branch, Dhanbad). The transaction details of the fine along with the transaction details of the semester fee paid earlier must be sent to feepayment@iitism.ac.in together, so that a **single fee receipt** can be issued which would be required to be uploaded by the student on the parent portal.
5. The students who paid the semester fee **on or before 30 September 2020** **but failed to upload the fee receipt** on the parent portal are required to send their transaction details to acad_so@iitism.ac.in by **20 October 2020**.
6. **Those who fail to complete the process as indicated in points 1 to 5 (as applicable) above by 31st October 2020 will be automatically deregistered for the semester.**
7. For issues related to online payment of fee, the guidelines shared on 14 September 2020 needs to be followed strictly. Emails sent to any other email id will not be responded to. In case of password related issue on parent portal, write to password@iitism.ac.in for resetting the password.
