NOTIFICATION

Subject: **A ONE-TIME OPPORTUNITY IS GIVEN TO THE PH.D. SCHOLARS OF 2017 AND ONWARD BATCHES WHOSE ACADEMIC PROGRAM WAS TERMINATED DUE TO NON-COMPLETION OF THE REGISTRATION PROCESS IN 2020-2021 WINTER AND EARLIER SEMESTER(S).**

It is notified that a one-time opportunity will be given to all the Ph.D. scholars of 2017 and onward batches, whose academic program was terminated due to **non-academic reason** (i.e., *non-completion of the registration process in 2020-2021 Winter and earlier semester(s)*) to register in 2021-2022 Monsoon Semester after reinstatement for continuing the Ph.D program.

If the academic program of the scholars was terminated due to **academic reason** (i.e., *showing inadequate academic performance in the academic activities and could not fulfil the eligibility criteria for continuing the Ph.D. program*), then the academic program of all such scholars will not be reinstated for availing this opportunity.

The Ph.D. scholars of 2017 and onward batches (*whose academic program was terminated due to non-academic reason*) will be allowed to register in the 2021-2022 Monsoon Semester after fulfilment of the following terms and conditions:

1. An **UNDERTAKING**, in the prescribed format (*Attached with this Notification*), duly endorsed by the Supervisor(s), to be submitted (in Hard Copy Only) to the Academic Section on or before **Friday, 30th July, 2021** along with the receipt of the Registration Fees of the entire period (starting from the date of admission) of the academic program.
2. No Undertaking Form will be considered, if it is not endorsed by the concerned supervisor(s) and all the registration fee receipts are not enclosed.
3. No request will be entertained for accepting the Undertaking Form after the specified date for whatsoever reason(s).
4. If any scholar fails to avail this opportunity and submit appeals in future for reinstatement in the academic program, then those appeals will not be accepted and the status of termination will remain standstill.

On verification of the submitted records, a list of reinstated scholars will be published, on **05th August 2021**, to do the followings:

- (a) Payment of Rs. 20,000/- (Rupees Twenty thousand only), as a fine for *non-completion of the semester registration(s)* within the specified duration.
- (b) Payment of Rs. 10,000/- (Rupees Ten thousand only), as a fine for *non-payment of the semester registration fees* within the specified duration.
- (c) Off-line Registration for 2021-2022 Monsoon Semester from **09th to 13th August 2021**.
- (d) Payment of all balanced semester registration fees (*excluding the terminated period*) along with applicable fine (as in Point (a) or Point (b)) and payment of the semester registration fees of 2021-2022 Monsoon Semester from **23rd to 27th August 2021**.

This notification is issued after obtaining approval of the competent authority.
