As per the Institutes of Technology Act, 1961 vide para-11 & 14 read in conjunction with the Statutes of IIT (ISM), Dhanbad vide para- 7(1) & 8 (1), Compositions of Board of Governors (BoG), SENATE, Finance Committee (FC) and Building & Works Committee (B&WC) of IIT (ISM), Dhanbad is given as under:

Composition of Board of Governors

1. Chairman – Nominated by the Visitor
2. Director – Ex-officio
3. **One Person** to be nominated by the Government of each state comprising the zone in which the Institute is situated from among persons who, in the opinion of that Government, are technologists or industrialists of repute.
4. **Four persons** having special knowledge or practical experience in respect of education, engineering or science nominated by the Council.
5. **Two Professors** of the Institute nominated by the Senate.
6. Registrar – Secretary

Composition of Senate

1. Director -Ex-officio - Chairman
2. Deputy Director - Ex-officio - Member
3. The Professors appointed or recognized as such by the Institute for the purpose of imparting instruction in the Institute.
4. Three persons, not being employees of the Institute, nominated by the Chairman from among educationists of repute, one each from the fields of science, engineering and humanities.
5. Heads of the Departments or Academic Centres or Schools other than Professors, as are not members of the Senate.
6. The Deans and Associate Deans other than Professors, as are not members of the Senate.
7. The Librarian
8. Six members of the Academic staff for their special knowledge appointed by the Chairman.
9. Registrar - Secretary
