TERMS AND CONDITIONS

1. The Scope of Work is enclosed as **Annexure-I**. Bidders are required to go through the Scope of Work carefully before submission of bids.
2. The bidder should not have been debarred or blacklisted by any Central / State Government. A self-attested certification to that effect must be uploaded with the technical bid in the prescribed format. The proforma of the certificate is enclosed with the tender as **Annexure-A**.
3. All the bids must be valid for a period of 180 days from the last date of submission. In, exceptional circumstances, prior to expiry of the original time limit, the Institute may request the bidders to extend the period of validity for a specified additional period beyond the original validity of 180 days. The request and the bidders' responses shall be made in writing. The bidders, not agreeing to such extensions, will be allowed to withdraw their bids without forfeiture of their Bid Security.
4. **EMD Exemption:** EMD exemption shall be given to those bidders who are registered with the Central Purchase Organization, NSIC, or MICRO and Small Enterprises (MSEs) as defined in the MSME Procurement Policy issued by the Department of Micro and Small Enterprises (MSME). To claim the exemption, the bidder must be offering goods manufactured by themselves or providing relevant services. Exemption will not be granted in case the bidder is acting as an agent for some other vendor.
5. **Instructions to the bidder of countries that share a land border with India (Rule 144(xi) GFRs).**
Any bidder from a country that shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Department for Promotion of Industry and Internal Trade (DPIIT). As per Office Memorandum No. F.7/10/2021-PPD (1) dated: 23.02.2023 issued by the Department of Expenditure (Ministry of Finance), Govt. of India, the bidder is required to submit an undertaking as per **Annexure-C**
6. **MII & Purchase Preference:**
The MII compliances and purchase preference shall be as per Govt. of India guidelines. All the bidders must upload undertaking as per **Annexure-B** with the Technical Bid.
7. **Submission of Bids:**
Technical bid - First sealed envelope: Should contain the technical bid consisting of all eligibility documents, all annexures (Annexure-A to Annexure E), PAN, GST, supportive documents related to experience criteria and EMD as asked in the tender document. All the above-mentioned documents should be submitted as Technical bid. This first sealed envelope should be super-scribed with 'Technical bid against

Tender no: WS-INS-236-25-26 dated 24.11.2025 – Decoration with Flood, Colored lights and Strips’.

Financial bid -Second sealed envelope: Should contain only **Annexure II (Financial Bid) (duly signed)**. The format provided in the tender document for the price schedule should be followed and any other format will be liable for rejection. This second sealed envelope should be super-scribed with ‘Financial Bid against Tender No: WS-INS-236-25-26 dated 24.11.2025–Decoration with Flood, Colored lights and Strips’.

Important Note: The above-mentioned two sealed envelopes should be put in another big sealed envelope and should be super-scribed as ‘Bid for Tender No: WS-INS-236-25-26 dated 24.11.2025 for ‘Decoration with Flood, Colored lights and Strips’. A bid submitted not in line with the above guidelines will be liable for rejection.

Tender/Bid may be dropped in the tender box kept in the Purchase & Stores Section, IIT (ISM) Dhanbad– 826004 (Jharkhand, India). Bids may also be submitted by Speed Post/ Registered post / Courier / By Hand in sealed envelope only within the due date of tender submission. IIT(ISM), Dhanbad will not accept such bid if delivered/submitted to the Purchase & Stores Section, IIT (ISM) Dhanbad after the submission deadline and such bids will be treated as late bids / non-responsive bids. It will be the sole responsibility of the bidders that their bid should be submitted/delivered as per bid submission deadline. IIT (ISM) Dhanbad will not be responsible for any delay or transit loss or late delivery of bids to the Institute. All bids/correspondences should be sent to the following address only:

8. Eligibility Criteria:

(a) Bidder must have executed one similar work of minimum Rs. 4,00,000 in Central/State Government/PSU/CFTI/Autonomous Body.

or

two similar works of minimum Rs. 2,50,000 in Central/State Government/PSU/CFTI/Autonomous Body.

or

three similar works of minimum Rs. 1,50,000 in Central/State Government/PSU/CFTI/Autonomous Body.

9. Evaluation Procedure:

Phase-I: Technical Evaluation

Technical evaluation will be done based on documents submitted by the bidder in the technical bid. Hence bidders are required to enclose all relevant documents along with the technical bid. Discrepancy in relevant supporting documents shall lead to the rejection of technical bids.

Phase-II: Financial Evaluation

- a. Financial bids of technically qualified bidders shall only be opened.
- b. The bid will be awarded to the L-1 bidder. In case of tie preference will be given to the bidder who have maximum experience in CFTIs.

10. Liquidated damages (LD): If a bidder fails to deliver the services or any part thereof within the period prescribed for delivery, the Institute shall be entitled to recover as liquidated damages a sum equivalent to 1% (one per cent) per week of the purchase order. The total damages shall not exceed 5% (five per cent) of the value of the purchase order.

11. Payment terms: 100% payment shall be made through NEFT/RTGS against submission of bills in triplicate, only after satisfying the following conditions:

- a. Successful delivery of service by the supplier.
- b. Submission of Performance security.

12. Performance Security

- a) To ensure due performance of the service, performance security is to be furnished by the successful bidder. The performance security should be furnished within 03 days of the award of the tender.
- b) Performance security should be for an amount of five per cent (5%) of the value of the supply order.
- c) Performance security may be furnished in the form of a Demand Draft/ Fixed Deposit Receipt / Bank Guarantee from a commercial bank in favour of Registrar IIT (ISM) Dhanbad, payable at Dhanbad. Performance security should remain valid for a period of **02 months**.
- d) The performance security will be refunded without any interest, provided that the performance is satisfactory.

13. Refund of EMD

- a) EMD will be refunded without any interest to the successful bidder on receipt of performance security.
- b) The bidder who is not qualified for the tender either in technical bid or on any other grounds, their EMD will be refunded within 30 days from the award of the contract.
- c) If a supply order is placed and the successful bidder fails or refuses to supply the item, in such case the EMD will be forfeited.

- 14. Cancellation of tender:** IIT (ISM) Dhanbad reserves the right to cancel the tender at any point in time without assigning any reason.
- 15. Legal:** Any dispute regarding the meaning, effect or interpretation of any clause of this contract/agreement shall be referred to the sole Arbitrator i.e. Director, IIT (ISM) Dhanbad who would act as the sole Arbitrator and proceedings of such arbitration shall be conducted in accordance with the provisions of the Indian Arbitration Act, 1940 or any statutory modification thereof. The venue of Arbitration shall be IIT (ISM) Dhanbad only and the language shall be English only. In case of litigation, if any, the District Court of Dhanbad (Jharkhand) shall have jurisdiction for any such litigation.
