Sub: Engagement of Sr. Consultant / Consultant in IIT (ISM), Dhanbad– regarding.

The Indian Institute of Technology (Indian School of Mines), Dhanbad invites applications for engagement of Retired Persons as Senior Consultant /Consultant on Contract Basis initially for a period of one year from the date of engagement which may be extended or curtailed as per the functional needs. The details regarding eligibility criteria, terms of references etc. are as under:

1. Senior Consultant (Electrical Engineering): 1 no.

- i. Should have retired from Central Government /Central PSUs/Central Autonomous Bodies/Reputed Industries.
- ii. Should have following Educational Qualification and Experience:

B.E/B.Tech. in Electrical Engineering from a recognised Institute with at least 20 years of post-qualification experience in the field of installation and maintenance of electrical installations of a large campus/ Industry which shall include installation and maintenance of DG sets, HT power stations, domestic electric supply etc. in any Organisation of Central Government /Central PSUs/Central Autonomous Bodies/Reputed Industries.

OR

Diploma in Electrical Engineering from a recognised Institute with at least 30years of post-qualification experience in the field of installation and maintenance of electrical installations of a large campus/ Industry which shall include installation and maintenance of DG sets, HT power stations, domestic electric supply etc. in any Organisation of Central Government /Central PSUs/Central Autonomous Bodies/Reputed Industries.

- iii. He should be capable of planning and implementing the electrical components of the projects of the Institute and also maintain all the electrical installations of the Institute.
- iv. The Senior Consultant will be paid a consolidated remuneration of Rs. 60000/- as lump sum per month. However, the consolidated remuneration together with the

pension drawn by the Senior Consultant from any Government/ Public source should not exceed the last pay drawn by him/her.

- v. Higher remuneration may be considered for the person with exceptional experience and qualifications, which shall not exceed the difference of last pay and Pension plus Dearness allowance on the date of engagement. The remuneration so arrived will remain fixed for one year.
- vi. In case the term of contract is extended beyond one year, 5% increase on the remuneration shall be payable.
- vii. No other allowances will be admissible to the Senior Consultant.

2. Consultant (Electronics): 1 no.

- i. Should have retired from Central Government /Central PSUs/Central Autonomous Bodies/Reputed Industries.
- ii. Should have the following Educational Qualification and Experience:

Three years Diploma in Electronics from a recognised institution with at least 20 years of post-qualification experience in the field of management/maintenance of Electronic equipment of Academic class rooms, Lecture Halls and Auditoriums; organising conferences, seminars, meetings, get-togethers etc. in any Organisation of Central Government /Central PSUs/Central Autonomous Bodies/Reputed Educational Institutions at a sufficiently higher position.

- iii. He should be capable of planning and implementing the activities relating to organisation of conferences, seminars, meetings, get-togethers of large scales, especially in reputed educational institutions.
- iv. The Consultant will be paid a consolidated remuneration of Rs. 45000/- as lump sum per month. However, the consolidated remuneration together with the pension drawn by the Consultant from any Government/ Public Source should not exceed the last pay drawn by him/her.
- v. Higher remuneration may be considered for the person with exceptional experience and qualifications, which shall not exceed the difference of last pay and Pension plus Dearness allowance on the date of engagement. The remuneration so arrived will remain fixed for one year.
- vi. In case the term of contract is extended beyond one year, 5% increase on the remuneration shall be payable.
- vii. No other allowances will be admissible to the Consultant.

General Terms and Conditions:

- i. The Sr. Consultant / Consultant shall not be entitled for any kind of allowances and residential accommodation.
- ii. The engagement of the Sr. Consultant / Consultant will be purely on Contractual basis.
- iii. The contract period of the Sr. Consultant / Consultant would be initially for a period of 1 year which may be extended or curtailed subject to review, at the sole discretion of

- this Institute. The period of engagement of Sr. Consultant / Consultant shall not exceed beyond the age of 70 years.
- iv. The Sr. Consultant / Consultant shall be eligible for 08 days of leave in a calendar year. This leave will not be carried forward in case the engagement period is extended by this Institute. Also, no payment in lieu of unutilised leave will be paid by this Institute at the time of expiry of contract.
 - v. The Institute may terminate the services of the Sr. Consultant / Consultant in case he/she is unable to achieve the assigned works within the time-frame or the work assigned to him/her is not satisfactory to the Institute.
 - vi. The Institute shall also reserve the right to terminate the services of the Sr. Consultant / Consultant at any time without giving any notice and also without assigning any reason. The engagement of Sr. Consultant / Consultant will not confer any right on the part of individual for permanent appointment to the post.
 - vii. Sr. Consultant / Consultant shall have to attend office six days a week.
 - viii. The Sr. Consultant / Consultant may be called in the Office on Saturdays, Sundays and other Gazetted Holidays or may be asked to sit late in the office after office hours, in case of exigencies of work. No extra allowances will be permissible for the same.
 - ix. The Sr. Consultant / Consultant may continue to draw pension and dearness relief on pension, if any, during the period of their engagement as Sr. Consultant / Consultant. This engagement as Sr. Consultant / Consultant shall not be considered as a case of re-employment.
 - x. No TA/DA shall be admissible to the Sr. Consultant / Consultants for joining the assignment. Sr. Consultant / Consultant will not be allowed any foreign travel at Institute's expenses. However, he/she may be allowed TA/DA for travel inside the country in connection with official work assigned to him/her.
 - xi. The Headquarters of Sr. Consultant / Consultant will be at Dhanbad.
 - xii. Any resultant dispute shall be settled within the jurisdiction of Dhanbad.
